Our default color space is Chrome Space 100 for transparency film, Adobe RGB for color negative film, Gray Gamma 2.2 for black and white film.

Film strips take more time and materials, therefore we ask that you cut out the individual frames you would like us to scan. If you do not cut your film, we will charge \$10 for each strip of 3 or more images we mount on our scanner.

Scans are transferred via FTP or can be burned onto an archival CD.

**INFO:**

All scans are checked for sharpness and cloned to remove air bubbles and scanning artifacts. We scan to retain all information in your film, creating an excellent starting point for a high quality digital file.

**NEGATIVE FILM:**

Negative film is scanned and converted to a positive state. Approximate density, black and white prints are set. No further post-scan cleanup or color/tonal correction is included.

**TRANSPARENCY FILM:**

Approximate density, color balance, black and white prints are set.
