Recovery Art Studio Privacy Policy Summary

Recovery Art Studio was created to provide education and information on the topic of art and healing around addiction, recovery and sobriety as well as related mental health conditions. We understand how important the privacy of personal information is to our users. We understand that your privacy matters and we respect your privacy choices. This summary of our privacy policy is intended to give you an overview of:

Information Collected About You

We may collect "Personal Information" about you – such as your name, email address, and device IP address upon the signing up for our newsletter, products or services, workshops, or subscriptions from our website or social media platforms.

We may collect "Non-Personal Information" – information that cannot be used to identify you – via Cookies, Web Beacons, Recovery Art Studio mobile device applications and from external sources, even if you have not subscribed with or provided any Personal Information to Recovery Art Studio.

What Choices Do I Have?

If you do not want your Personal Information used by Recovery Art Studio as provided in this Privacy Policy, you should not subscribe or download our products or services. You may, at any time, simply delete the Recovery Art Studio app from your mobile device or unsubscribe to any emails by clicking the unsubscribe link in every email we send. Most browser software can be set to reject Cookies, and you can opt out of Cookies for several Ad Servers by visiting the Network Advertising Initiative gateway opt-out site.

How Information Collected About You Is Used

We may use information we collect about you to: process purchases of original art or fine art reproductions/photographs; administer your newsletter account; provide you with access to all registered workshops and classes and related materials; respond to your inquiries and send you administrative communications; obtain your feedback on our products and services; statistically analyze user behavior and activity; provide you with more relevant content and advertisements; conduct research and measurement activities; or send you personalized emails or secure electronic messages pertaining to your interests, including news, announcements, reminders and opportunities.

We may combine Personal and Non-Personal Information collected by Recovery Art Studio about you, and may combine this information with information from external sources. Third parties may also use Non-Personal Information in order to display advertising that reflects the interests and preferences of our user community.

With Whom Do We Share Your Information?

Recovery Art Studio will not disclose any Personal Information about you unless specifically agreed to you by you or: to comply with legal requirements, such as a law, regulation, search warrant, subpoena, or court order; to our vendors and suppliers in the course of their provision of products or services to Recovery Art Studio; in the event of a corporate change in control resulting from, for example, a merger, a sale of assets, or bankruptcy; or in special cases, such as in response to a physical threat to you or others.

Recovery Art Studio does not make your Personal Information available to third parties for their marketing purposes.

Recovery Art Studio Privacy Policy

Recovery Art Studio understands how important the privacy of personal information is to our users. This Privacy Policy will tell you what information we collect about you and about your use of Recovery Art Studio and its services. It will explain the choices you have about how your personal information is used and how we protect that information. We urge you to read this Privacy Policy carefully.

This Privacy Policy applies to Web sites owned and operated by Recovery Art Studio.

Information Collected About You Personal Information

Registration

Newsletters & Emails to You

Upon the creation of your subscription account to Recovery Art Studio, you will be given the option of providing us with Personal Information in order to receive recurring informational/promotional newsletters – such as a newsletter relating to new, monthly issues, addiction, recovery, sobriety, the healing power of art or other value added information we deem appropriate via email from Recovery Art Studio and/or directly from third parties.

When you sign up for our email newsletters or at any time, you can choose to opt out of receiving additional promotional newsletters from Recovery Art Studio or our Sponsors. You can unsubscribe from a newsletter by: following the directions included at the bottom of the newsletter.

Market Research

From time to time, Recovery Art Studio may conduct online research surveys through email invitations, pop-up surveys and online focus groups. When participating in a survey, we may ask you to enter Personal Information. The Personal Information you submit in a survey may be used by Recovery Art Studio for research and measurement purposes, as described below, including to measure the effectiveness of content, advertising or programs. When our market research surveys collect Personal Information we will not knowingly accept participants who are under the age of 18. Market research surveys conducted by or on behalf of Recovery Art Studio will contain a link to this Privacy Policy.

Community, Blogs, and Other Public Forums

Recovery Art Studio may feature community areas and other public forums where users with similar interests or conditions can share information and support one another or where users can post questions for experts to answer. We also provide subscribers access to all Recovery Art Studio products and services. Our communities are open to the public and should not be considered private.

Emails You Send to Recovery Art Studio

This Privacy Policy does not apply to information, content, business information, ideas, concepts or inventions that you send to Recovery Art Studio by email. If you want to keep content or business information, ideas, concepts or inventions private or proprietary, do not send them in an email to Recovery Art Studio.

Non-Personal Information

Even if you do not register with or provide any Personal Information to Recovery Art Studio, we collect Non-Personal Information about your use of the Recovery Art Studio Web Sites. "Non-Personal Information" means information that we cannot use to identify or contact you. We may also acquire Non-Personal Information about our users from external sources. While you may use some of the functionality of Recovery Art Studio without registration, full access to the Recovery Art Studio content and contributors requires that you subscribe with Recovery Art Studio.

Cookies and Web Beacons

We collect Non-Personal Information about your use of the Recovery Art Studio Web Sites and your use of other web sites through the use of Cookies and Web Beacons, "Cookies" are small data files that are stored on the hard drive of the computer you use to view a web site. Every computer that accesses the Recovery Art Studio Web Sites is assigned a different cookie by Recovery Art Studio. Recovery Art Studio tools that collect and store Personal Information allow you to correct, update or review information you have submitted by going back to the specific tool, logging-in and making the desired changes. We will also retain your Personal Information as necessary to comply with legal obligations, resolve disputes and enforce our agreements.
