Artwork Commission Order Form

Please Be Aware:

Commissioning is the process by which an Artist creates a work of art on a Client's request. Requesting a custom painting or ink/pencil sketch provides the unique opportunity for a Client to own artwork specifically created for them.

It's important to remember that commissioning an oil painting or ink/pencil art is unique. Clients must allow for creative freedom and gauge expectations accordingly.

Commission requests must be within the parameters of the mediums of oil painting, pencil, or ink. When requesting a commission, you will need to define your desired color palette and size. The Artist will work with you to color match (if desired) and to best understand your wishes.

Commissions for artwork start at \$20 for small pencil art to \$60 for larger pieces but vary slightly for detail and subject. Oil paintings start at \$40 for small landscape pieces and range to as much as \$1000 for larger canvases with more detail and subject matter. Contact me to discuss your project and budget.
