Client may terminate this Agreement by providing written notice. Upon termination:

- The 30% deposit is non-refundable.
- If partial work has been completed, Artist retains all rights and may repurpose the artwork.

## **VIII. Warranty of Originality**

Artist warrants that the Work is original and does not knowingly infringe on any third-party rights.

## IX. Entire Agreement
